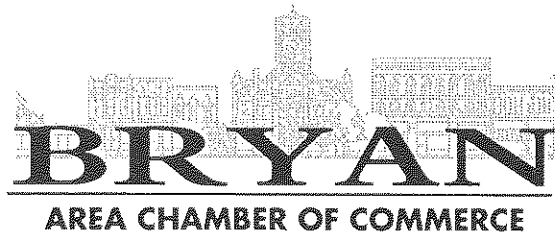

Nominations for Business of the Year

A business may nominate themselves, or another business. The nomination form must be completed by the nominee no later than December 15 of the year. The award will be given at the January Annual Meeting following the December nomination deadline. The following Criteria is used in determining the winner of the Business of the Year.

Criteria for Small / Medium Business of the Year

1. Nominee must be a member in good standing of the Bryan Area Chamber of Commerce in membership level A or B. (29 Employees or less)
2. Nominee must be an active business in the Bryan Area for at least 3 years.
3. Active leadership in the Bryan Community (Ex.—Volunteerism, Community Promotion, Leadership)
4. Make strides to enhance Economic Development in the Bryan Area. (Ex.—Job Growth, Workforce Development)

Criteria for Large Business of the Year

1. Nominee must be a member in good standing of the Bryan Area Chamber of Commerce in membership level C or D. (30 Employees or more)
2. Nominee must be an active business in the Bryan Area for at least 3 years.
3. Active leadership in the Bryan Community (Ex.—Volunteerism, Community Promotion, Leadership)
4. Make strides to enhance Economic Development in the Bryan Area. (Ex.—Job Growth, Workforce Development)

Who can Nominate?

Anyone may nominate a member business or may nominate their own business. The chamber reserves the right to request further information to complete the nomination process. Applications are judged by a committee of Chamber Board Members and non-board member committee members. Nominations will only be kept for one year and will not be considered after the award is given. Non-Business or Friend Status members of the Bryan Chamber are not eligible to receive either category award.
